Principal, GEMS Arts & Science College, Ramapuram, Malappuram submitted application, vide paper read as first, for starting M.Sc Geology and M.Sc Biotechnology programmes during the academic year 2019-20. The then Inspection Commission recommended for starting of M.Sc. Geology programme only and the recommendation was forwarded to Govt. Based on the recommendation of the University, Govt. issued administrative sanction and NOC in respect of M.Sc Geology programme. Additional affiliation was granted to M.Sc Geology programme with an intake of 10 seats for the academic year 2019-20, vide U.O. cited second.

- 2. In view of the Judgement dated 20/02/2019 of Hon'ble High Court of Kerala, in WP(C)1736/2019, the Syndicate held on 18/05/2019, vide item No. 2019.347*, resolved to conduct re-inspection in the above college to re-assess the facilities therein. The inspection commission conducted re-inspection at the college and submitted report by recommending M.Sc. Biotechnology programme also for the academic year 2019-20 and recommendation was forwrded to Govt. vide paper read as third above.
- 3. In the event of non-receipt of the consent from the Govt., College approached Hon'ble High Court of Kerala, filing a Writ Petition No.20858 of 2019 and the Hon'ble Court, vide paper read as fourth, disposed of the Writ Petition directing University to pass orders on the application for additional affiliation in respect of starting of M.Sc Biotechnology programme independent of the stand taken by the Govt. that only one course would be allowed. The orders shall be passed in the light of the

As per the reference 1st cited, it has been ordered to grant marginal increase of seats on the sanctioned strength, within the statutory limit for admission to UG/PG programmes (in Arts and Science and Oriental title colleges) for the academic year 2019-20 as detailed below-

- a. To grant a minimum marginal increase of 20% on the sanctioned strength to all programmes under Government and Aided stream and also upto the statutory maximum on request from the Principals concerned.
- b. To grant marginal increase of upto 20% on the sanctioned strength to self-financing programmes, subject to the submission of application along with required fee.
- C. To grant marginal increase of seats upto the statutory maximum of the programmes which are conducted by IHRD/ LBS/ Co-operative agencies, based on the requests from the Principals concerned.
- 2. Accordingly, vide University Orders read as 2nd to 4th above, marginal increase of seats have been granted to the affiliated colleges for the academic year 2019-20.
- 3. The Government of Kerala, vide GO(MS)-176/2019/HEDN dated 21/06/2019, accorded sanction to enhance the number of seats in unaided/self financing colleges from the year 2019-20, subject to the compliance of the regulations of the University and also without prejudice to the existing number of seats. The Syndicate meeting held on 22/06/2019 considered the matter and resolved to implement the afore mentioned Government Order and also resolved to take necessary steps to amend the existing clauses 31 (d), (e) and (f) of the Chapter-23 of CUFS 1977, after obtaining permission from the Govt. It was also resolved to sanction marginal increase of seats from this academic year itself to all colleges on fulfilling the infrastructural requirement based on the spirit of the above Govt Order and considering the exigent situation faced by the students in the jurisdiction of the University of Calicut in anticipation of the concurrence of the Government and completion of the statute amendment process. It was further resolved that the Syndicate sub-committee will finalise the number of seats to be allotted to the colleges as marginal increase by 28/06/2019.
- 4. Consequently, as contained in the University Order cited 5th, orders were issued by framing a time schedule for submitting and processing the applications for additional marginal increase for the year 2019-20. Accordingly, applications for additional marginal increase have been received from various affiliated colleges.
- 5. The Syndicate sub-committee meeting held on 28/06/2019 considered the whole applications received for additional marginal increase for the year 2019-20, and recommended to grant additional marginal increase to the affiliated colleges, based on the applications and the declaration furnished thereon, observing the following maximum PRINCIPAL limits.

- Sanction has been accorded by the Vice Chancellor, vide item No. 6th read above, to approve and implement the above recommendation of the Syndicate sub-committee, subject to the ratification by the Syndicate.
- 7. The additional marginal increase of intake for the year 2019-20 is, therefore, sanctioned to the various programmes in following affiliated colleges as per the detailed list attached herewith, in anticipation of the concurrence of the Government and completion of the statute amendment process.
 - 8. The marginal increase so sanctioned shall be subject to the following general conditions.
 - a. The marginal increase sanctioned is purely provisional and specifically for the academic year 2019-20 and should not be taken as an addition to the sanctioned strength.
 - b. The seat ratio share between different quota (general, management, community etc) will be the same as that was followed in the case of the actual sanctioned strength of the programme.
 - c. The marginal increase is sanctioned subject to the condition that it should not involve any additional staff and or additional financial commitment either to the Government or to the University.
 - d. The additional marginal increase sanctioned is based on the affidavit submitted by the Principal that the college has sufficient institutional and infrastructural facilities required for accommodating the marginal increase.
 - e. The admission to the marginally increased seats should be made strictly as per the admission rules prescribed by the University and subject to the the continuation of provisional affiliation for the academic year.
- 9. The Principal should strictly adhere to the above directions while admitting students in their college in order to avoid any further proceedings from the University.
- 10. University Orders cited 2nd to 4th cited are modified to this extent. Orders are issued accordingly.
