# **<u>1. EXECUTIVE SUMMARY</u>**

# **1.1 INTRODUCTION**

The Institution was established in Ramapuram on the outskirts of Perinthalmanna in the year **2008**. The College is affiliated to University of Calicut and is recognized by the UGC under 2(f) of UGC Act 1956. The College is offering **14 UG** programs and **6 PG** programs. The Campus is spread over 10 acres of land surrounded by hillocks and lush green Paddy fields.

Since the institution is located in an underdeveloped backward area of the hilly district of Malappuram, it has become an asylum for thousands of students who are hailing from rural and backward areas. Even the very name of the district 'Malappuram' denotes the meaning 'on the hilltop' is an indicator that shows the geographical features of the area.

To address the general educational backwardness of the backward class, which form the majority of the population, the state government launched a massive awareness cum training program for the stakeholders by the name **'Vijaya Bheri'**(Success Trumpet Call) with the aim of raising the pass percentage of high school and plus two students of the district. It created an unprecedented 100% pass of students in Plus Two. It resulted in the situation where thousands of plus two passed were not able to get seats in degree programs in the district.

There were only very few Government and Aided colleges in the district to meet the demands of the students. Thus the educational enthusiasts and social workers formed a Co operative society by name **GEMS Cooperative Society** under the **Chairmanship of Constituency MLA**, in which people from all walks of life irrespective of the Caste, Creed, and Politics joined as members of the Co Operative Society to start a College to cater to the educational needs of the people. Thus, **GEMS College** was founded.

**BEST PRACTICE I** 

"Prithvi Sudhar" - No to Pollution, Yes to Solution

#### Objectives

The primary objective of the practice is to **tackle the escalating issue of Plastic pollution by raising awareness and implementing effective solutions within the institution's ecosystem** and the surrounding community. **With global plastic production reaching alarming levels of 400 million tons annually**, the institution recognized its integral role in combating this pervasive problem, particularly in its **semi-rural setting**.

#### **Contextual Features**

Against the backdrop of World Environment Day 2018's theme, "Beat Plastic Pollution," the institution

embarked on a mission to address plastic pollution starting from its campus and extending to neighboring villages and towns. As an examination center for distance education students, managing litter, including plastic waste, became a pressing concern. Thus, the institution initiated the "No to Pollution and Yes to Solution" campaign, **harnessing technology such as bioremediation to convert plastic waste into manure.** 

## **The Practice**

- GEMS stands as the pioneering institution in the country to employ bioremediation techniques to mitigate plastic pollution, earning a patent for its innovative approach. NSS volunteers actively participate in collecting and treating low-density polyethylene (LDPE) wraps on campus, converting them into nutrient-rich manure through co-composting with agro-waste and bacterial solutions. This sustainable practice not only reduces plastic waste but also promotes bio-farming.
- The NSS volunteers over the years are continuing the practice-one batch after another. NSS volunteers collect the LDPE (Low Density Poly Ethylene) wraps during their campus cleaning drive once in every month and bring the waste to the treatment site inside our campus.
- Then the plastic wraps and covers are put on soil heaps where they are mixed with bacterial solution prepared in our labs with added coir pith and cow dung. The heap is kept for 180 days and aeration is done by simply mixing the heap every week. After 180 days, the waste is seen converted to rich manure which can be utilized for bio farming purpose.

#### **Evidence of Success**

• The success of the practice is evident through the reduction of waste within the campus and the flourishing growth of vegetables nurtured with the converted manure. Furthermore, students are educated about the harmful effects of plastic pollution and the potential for converting plastic waste into beneficial resources. The practice has garnered interest from local government bodies, indicating its scalability and impact beyond the campus.

#### **Challenges Faced**

• While laboratory support mitigated challenges, the practice encountered setbacks during the pandemic-induced lockdown, disrupting operations temporarily. Additionally, climatic variations, such as heavy rains and temperature fluctuations, affected the biodegradation process, highlighting the need for adaptive strategies.

#### **Future Directions**

• Despite challenges, the institution is planning to expanding the practice to nearby schools and institutions, contributing to soil rejuvenation and environmental sustainability. Through continued innovation and community engagement, "Prithvi Sudhar" aims to be a beacon of hope in the fight against plastic pollution, embodying the institution's dedication to environmental stewardship and societal well-being.
